The CHC33015 - Certificate III in Individual Support (Disability) is designed to produce job ready candidates who can provide a person-centred approach in the growing community care industry. This qualification reflects the role of workers in the disability community and/or residential setting.

Course Delivery

The CHC33015 - Certificate III in Individual Support is delivered within 12 months. Students can choose one of the following delivery options:

- Classroom environment: Weekly classroom sessions at our delivery locations.
- Flexible delivery: Self-paced learning with one-on-one contact with a trainer.

Eligibility Criteria*

The Certificate 3 Guarantee Program has the following eligibility requirements:

- Be a permanent resident of Queensland aged 15 years or above, and \checkmark
- No longer at school (with the exception of VET in school students) and,
- Not have completed or be enrolled in a Certificate III (or higher qualification), this does not include gualifications completed at school, and
- Be an Australian or New Zealand citizen or Australian permanent resident (including \checkmark humanitarian entrants), or a temporary resident with the necessary visa and work permits on the pathway to permanent residency.



Certificate 3 Guarantee Program CHC33015 Certificate III in Individual Support (Disability)



Course Requirements

To achieve a CHC33015 - Certificate III in Individual Support 13 units must be completed including 7 core units and 6 elective units and complete 120 hours of vocational work placement.

For the Disability stream vocational work placement, students will require the following:

- Undergo a workers screening clearance and be cleared to work in this industry. In some instances students will be required to provide a Police Check*
- Blue Card

*Police check must be completed within 3 months of commencing placement ^Students may be required to complete their First Aid prior to commencement of their vocational work placement. All cards need to be obtained for submitted application prior to placement. Students will require the latest vaccinations stipulated by the workplace or relevant government health authority, to enable the student to work in vocational placement (ie Flu, COVID etc).

Certificate 3 Guarantee Program

The Certificate 3 Guarantee Program is funded by the Queensland Government and supports eligible individuals to complete their first post-school Certificate III level qualification and increase their skills to move into employment, re-enter the workforce or advance their career.

Aurora Training Institute is a Skills Assure Supplier for the delivery of this Certificate III qualification. As you can only access the Certificate 3 Guarantee Program funding once, it is important that you consider your training options carefully and ensure they align with your chosen career pathway.

As a condition of your enrolment, you will be required to complete a student training and employment survey within three months of finishing or discontinuing your training.

Student Contribution Fee

The Student Contribution Fee under the Certificate 3 Guarantee Program is \$2 per unit and a **total cost of \$26 (concessional and non-concessional)**. This fee represents the total cost to the student to enrol, undertake training and be awarded the qualification and will be required to be paid before training commences.
