#### Course Overview

If you are passionate about shaping young minds, the CHC50125 Diploma of Early Childhood Education and Care prepares you to take on leadership roles in the early childhood sector.

This qualification teaches you how to design and implement curriculum, nurture children's development, manage compliance with regulations, and lead and support a team of educators to create safe, inclusive, and engaging learning environments.

#### Mode of delivery and training arrangements

This qualification is delivered over 18 months.

- **Online delivery:** Self-paced learning with one-on-one contact with a trainer.

#### Eligibility Criteria

Eligible Students must meet the following criteria:

- Aged 15 years or older.
- Not be a school student.
- Be a permanent Queensland resident.
- Be an Australian citizen, or Australian permanent resident (includes humanitarian entrant), or a temporary resident with the right visa and work permits on the pathway to permanent residency, or a New Zealand citizen.
- Not already have a Certificate IV or higher qualification (including tertiary qualification) completed within the last 10 years (qualifications started as a school student, and foundation skills qualifications, do not count).
- Not be enrolled in any other qualification, whether funded or unfunded, except for foundation skills qualifications.

To achieve a CHC50125 Diploma of Early Childhood Education and Care, 15 units must be completed including 12 core units and 3 elective units.

## Career BOOST

Career Boost provides eligible individuals with one subsidised training place in either a Certificate IV, Diploma, or Advanced Diploma qualification under the general training pathway or a higher-level apprenticeship/traineeship at certificate IV or above and up to two subsidised skill sets.

Aurora Training Institute is a Skills Assure Supplier under this program for the delivery of this qualification.

The Program delivers training designed to help individuals develop the higher-level skills necessary to secure employment, advance their careers, or progress to further education and training through related university or tertiary qualifications.

## Student Co-Contribution Fee

The Student Co-Contribution Fee under the Career BOOST (General Training) Program is \$3.00 per unit and a total cost of \$45 (Concessional and non-concessional) for this qualification. This fee represents the total cost to the student to enroll, undertake training and be awarded the qualification.
